

- Uplifts the CFJ, RWR, and Highway of Tears visions for systemic change, rooted in truth, human rights & safety
- 15 Strategies and 42 Lines of Action
- Identifies Barriers and Proposes
   Recommendations to address them
- It is a living document



### BCFNJC's Council Strategic Priorities – Coyote's Version

Coyote's Version uses storytelling to help guide prioritization grouping priorities into what they call "The Berry Patch of Justice" with:

- Ripe and ready for action (short-term berries, 1-3 years),
- Patience required (medium-term berries, 4-6 years), and
- For those big, juicy dreams (long-term berries, 7-10 years).

## Pick These Berries Now-They're Ripe for Action (Short-Term Priorities)

These berries are ripe, ready, and practically jumping into my paws. The Elder said, "Pick these first, Coyote." Naturally, I agreed, after all I have excellent taste. These are the "act-now" priorities.

- Strategy #8 Man Camps, Resource Extraction and Land Exploitation
- 2. Strategy #9 Crisis Response
- **3. Strategy #15** Legislation and Policy (directly related to Strategy 8 & 9 only)



Strategy #8 Man Camps, Resource Extraction and Land Exploitation

**Objective:** Recognizing the well-known effects that the ongoing influx of man camps has on our Indigenous women, girls, and 2SLGBTQIA+, specifically in northern remote and rural areas, it is imperative to take more precautions. This plan will ensure that preventative and safeguarding measures are in place to end the gendered and racialized land-based violence caused by resource extraction and toxic masculinity in BC.





## Strategy #9 Crisis Response

**Objective:** Enhancing the work to guarantee social and economic systems are in place to prevent/reduce victimization of Indigenous women, girls, and 2SLGBTQIA+ this strategy ensures that Indigenous women, girls, and 2SLGBTQIA+ who go missing and/or are found murdered receive a prompt and efficient response. Relevant partners across jurisdictions will ensure communication and consistency, ending the systemic discrimination and racism that has resulted in a lack of care and attention.

## Strategy #15 Legislation & Policy

as it relates to Strategy 8 & 9





**Objective:** Legislation and policies will reflect consideration and space for Indigenous worldviews, with particular attention and space to autonomy and self-governance. Indigenous women, girls, and 2SLGBTQIA+ will not feel targeted by laws that are used to criminalize them but rather a system where First Nations can make space to revitalize traditional justice practices.
